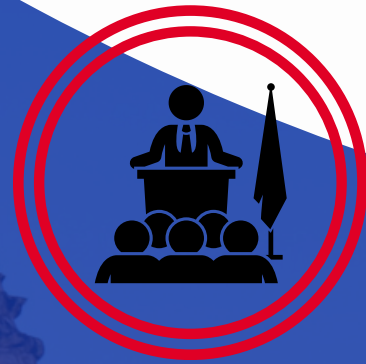


Why Cambodia?

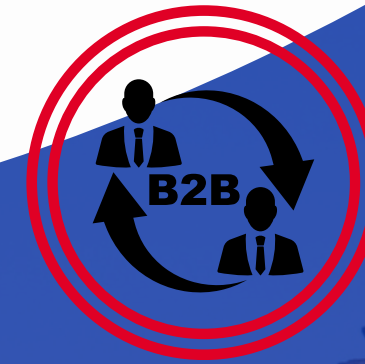

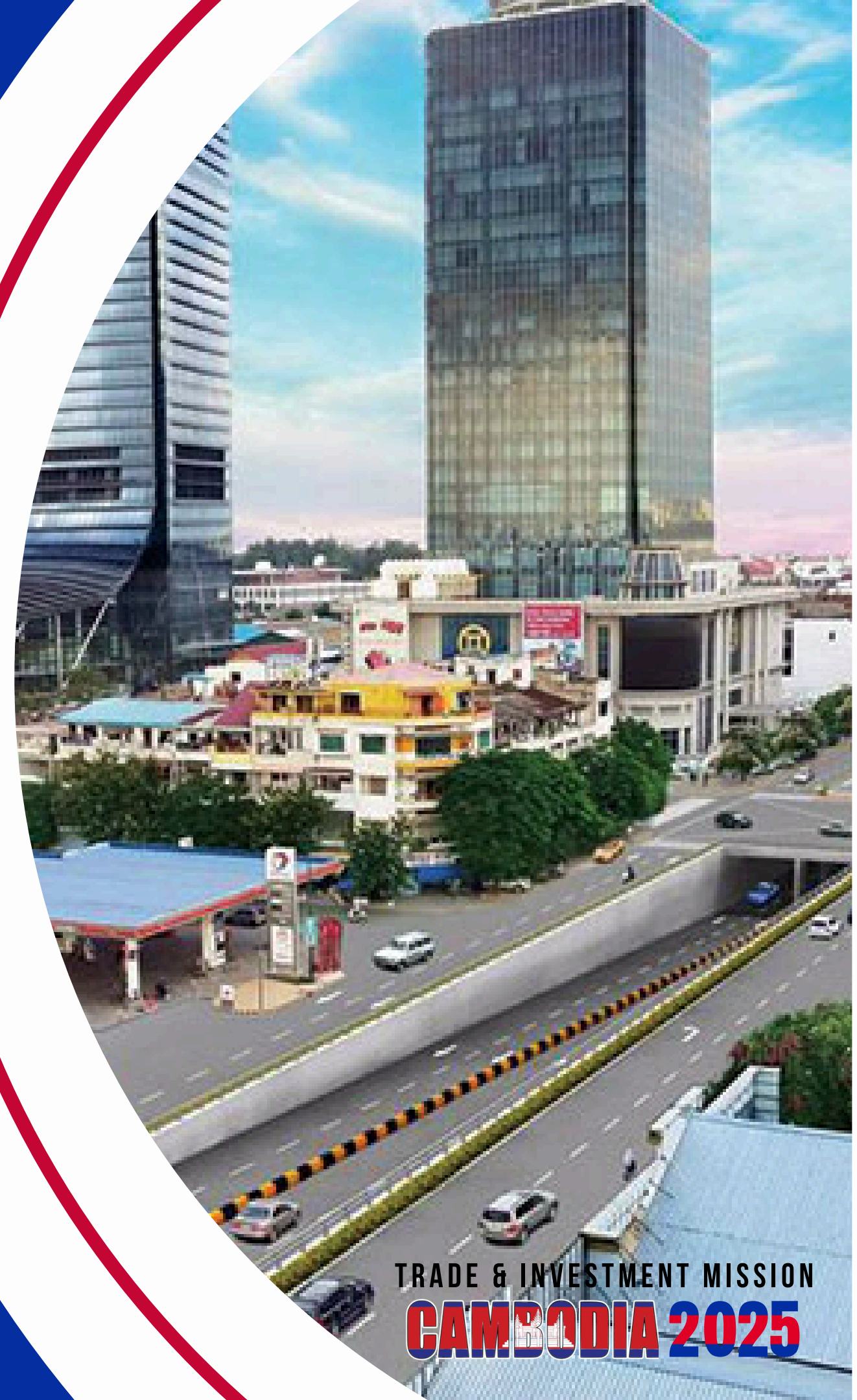
