A New Chapter in Bilateral Cooperation

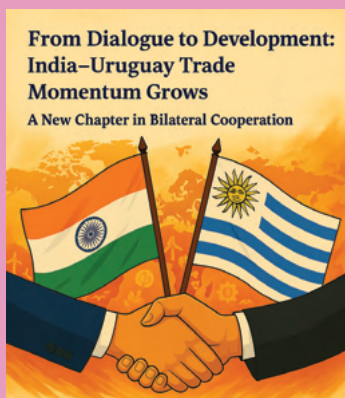

The trade agenda during this phase emphasized supply chain resilience, investment in clean technologies,

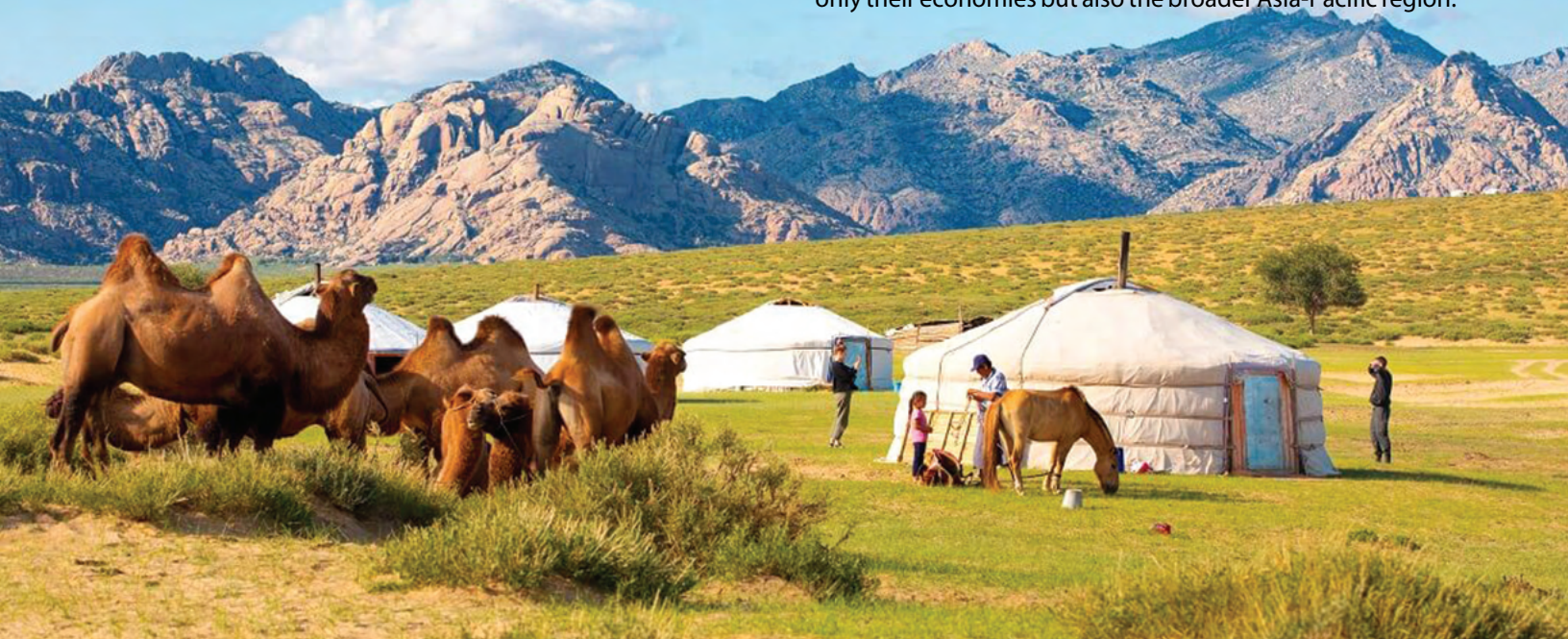

GTTCI's Strategic Engagement in Moscow and SPIEF 2025: Advancing India–Russia Economic Diplomacy and Eurasian Cooperation

St. Petersburg, Russia, 18th-21st June 2025



In June 2025, the Global Trade & Technology Council (India) (GTTCI), under the able leadership of Chairperson Dr. Rashmi Saluja, embarked on a significant diplomatic and economic mission to the Russian Federation. Accompanied by Founder President Dr. Gaurav Gupta and Chief Advisor Mr. Rakesh Asthana, the delegation first travelled to Moscow from 16th to 18th June, followed by active participation in the St. Petersburg International Economic Forum (SPIEF) from 18th to 21st June. The dual-purpose visit was aimed at strengthening bilateral trade and investment ties between India and Russia, while also contributing meaningfully to regional dialogues around digital transformation, innovation, and inclusive economic development across Eurasia. Through high-level institutional meetings, strategic financial dialogues, and panel discussions with global leaders, GTTCI reaffirmed its mission to serve as a bridge between India and the global economic community.

Engagement with the Russian Union of Industrialists and Entrepreneurs (RSPP) – Institutional Partnership Dialogue

On 16th June in Moscow, GTTCI initiated a productive and forward-looking discussion with the Russian Union of Industrialists and Entrepreneurs (RSPP), one of Russia's most



influential and respected business associations. The meeting was hosted by Mr. Sergey Krasilnikov, Vice President of RSPP, and led by Dr. Rashmi Saluja. At the heart of the dialogue was a mutual aspiration to establish a more structured, permanent, and responsive platform for India–Russia business cooperation. Among the key proposals discussed was the creation of a Russia Trade Desk in India under GTTCI's framework to facilitate active and timely engagement between Russian corporations and Indian enterprises. In parallel, the delegation proposed the opening of a GTTCI Representative Office in Moscow to act as a local hub for



Indian exporters, investors, and innovators seeking Russian collaboration. Dr. Saluja articulated the long-term value of such institutional linkages in creating resilient supply chains, investment corridors, and joint innovation networks. The parties also explored the possibility of co-developing platforms for B2B matchmaking and facilitating cross-border technology transfers. The meeting concluded with a shared commitment to build on this momentum and take forward the proposals through a phased and mutually agreed-upon implementation plan.

Strategic Dialogue with Gazprombank (GPB) – Cooperation via the Electronic Trading Platform (ETP)

On 17th June, the delegation held a comprehensive and highly strategic meeting with Gazprombank (GPB), a major financial institution known for its innovation-driven approach and robust procurement infrastructure. The meeting, facilitated by Ms. Angelina Morgun and Ms. Polina Bykova from the bank's International Department, focused on several cooperation tracks centered around GPB's Electronic Trading Platform (ETP). GPB proposed that GTTCI assume the role of an official aggregator of Indian suppliers, enabling Indian businesses to access Russian procurement opportunities directly through the ETP interface. GTTCI responded enthusiastically, pledging to identify reliable Indian suppliers from various sectors and coordinate their participation in upcoming tenders and projects.

Further discussions explored the potential for bilateral trade in key raw materials such as urea and essential industrial inputs. GPB expressed its willingness to facilitate supply, contingent on the submission of product specifications and import requirements from India. An interesting component of the dialogue was GPB's introduction of detonation diamond grit—a precision-grade material used in aerospace and high-tech industries—and their interest in launching

it in the Indian market through GTTCI's trade facilitation network. The meeting also included a detailed discussion on the concept of developing a bonded logistics zone in Russia for Indian exporters, which would allow warehousing and customs facilitation under preferential arrangements. Both parties agreed to collaborate in showcasing the progress of these initiatives at the BRICS International Forum during SPIEF 2025, beginning with pilot-level engagement and a digital demonstration of the ETP to GTTCI's Indian supplier base.

Dialogue with VTB Bank – Structuring the India–Russia Investment Fund and Ruble–Rupee Mechanisms

On 18th June, GTTCI engaged in a crucial dialogue with VTB Bank in Moscow, where Ms. Olga Basha, Member of the Board, welcomed the delegation for a forward-looking conversation on financial cooperation and investment architecture. The session focused on the conceptualization of an India–Russia Investment Fund, envisioned to disburse ruble-denominated capital in India to support startups, MSMEs, and technology-driven ventures. Dr. Saluja and Dr. Gupta presented a compelling case for the fund, emphasizing how such a financial instrument could empower grassroots enterprises, foster innovation, and reduce India's dependency on global capital markets.

Another key agenda of the discussion was the facilitation of ruble–rupee bilateral trade arrangements. Both sides acknowledged the need for mechanisms that could enhance currency parity and reduce trade frictions caused by dollar





volatility. VTB expressed keen interest in further developing these ideas and agreed to explore structured proposals to be announced at SPIEF. This engagement underscored GTTCI's commitment to reimagining the financial backbone of India–Russia trade relations with a focus on local currencies and shared investment frameworks.

GTTCI at SPIEF 2025 – Amplifying India's Role in Eurasian Growth

The second leg of GTTCI's visit began on 18th June with the

delegation's participation in the St. Petersburg International Economic Forum (SPIEF), widely recognized as one of the world's leading platforms for global economic dialogue. GTTCI's leadership featured prominently across key sessions focused on technology, women's empowerment, investment, digital platforms, and South–South cooperation. The delegation's presence was marked by substance, strategy, and an unwavering focus on inclusive growth.

Dr. Rashmi Saluja's Address on Digital Platforms and Global South Integration - Session: "Develop or Absorb? Global Digital Platforms and Their Impact on the Economies of Eurasia and the Global South"

On 19th June 2025, Dr. Rashmi Saluja, Chairperson of the Global Trade & Technology Council of India (GTTCI), addressed the high-level session titled "Develop or Absorb? Global Digital Platforms and Their Impact on the Economies





of Eurasia and the Global South” at the St. Petersburg International Economic Forum (SPIEF). The panel brought together an esteemed line-up of global thinkers and policymakers from the Russian Federation, China, the Kyrgyz Republic, Uzbekistan, and India. Dr. Saluja shared the stage with senior officials and business leaders representing ministries of economic development, digital innovation bodies, and regional trade organisations from these nations, collectively contributing to a rich and diverse exchange of perspectives. In her speech, Dr. Saluja emphasized the role of digital platforms in empowering small and women-led enterprises across the Global South, citing examples

from GTTCI’s on-ground initiatives in India and its ongoing collaborations with Uzbek institutions. She underscored how digital commerce removes traditional entry barriers, offering entrepreneurial pathways to those in rural and underserved regions, especially women. Her remarks highlighted the urgency of building harmonised regulatory mechanisms and digital infrastructure to bridge the growing divide in global digital access. Her inclusive and pragmatic approach to digital diplomacy was widely appreciated by fellow speakers and delegates present at the forum.

Dr. Gaurav Gupta’s Call for Stronger SCO Business Synergies - Session: “SCO Business Agenda 2025”

Later the same day, Dr. Gaurav Gupta, Founder President of GTTCI, delivered a compelling address during the session titled “The New SCO Business Agenda in Today’s World,”





which was convened to explore future-ready economic partnerships within the Shanghai Cooperation Organisation (SCO) framework. The session featured a distinguished panel including Mr. Nurlan Ermekebaev, Secretary General of the SCO; Mr. Sergey Katyrin, President of the Chamber of Commerce and Industry of the Russian Federation; and Mr. Ren Hongbin, Chairman of the China Council for the Promotion of International Trade (CCPIT). Also present were senior delegates from Kyrgyzstan, Uzbekistan, and India, all of whom reinforced the importance of strengthening multilateral cooperation within the region. Representing India's private sector, Dr. Gupta articulated a forward-looking vision for SCO-centric economic collaboration and





proposed concrete ideas such as the creation of a SCO Digital Cooperation Hub, a joint investment and trade promotion fund, a regional business visa regime, and the harmonisation of customs and logistics frameworks. He also cited recent MoUs signed by GTTCI with prominent chambers of commerce in Russia, Kazakhstan, Kyrgyzstan, and Uzbekistan, and stressed the need to translate these into tangible outcomes through trade exhibitions, technology partnerships, and coordinated policy actions. His contribution was noted for balancing regional sensitivity with practical ambition, and was strongly endorsed by the panel for its strategic foresight and commitment to multilateralism.

Dr. Saluja at the Women and Innovation for Healthy Society Forum - Session: “Women’s Contribution to Technological Development and Innovation for a Healthy Society”

In another influential engagement on 19th June 2025, Dr. Rashmi Saluja participated in the thematic session titled “Women’s Contribution to Technological Development and Innovation for a Healthy Society.” The panel featured several prominent voices in the field of gender equity and innovation, including Dr. Elena Ivanova, Director of the Russian Women in Technology Association; Ms. Salima Begum from the Pakistan Digital Health Alliance; and Dr. Olga Kornienko,



Director of the Belarusian Center for Gender Innovation. Dr. Saluja’s remarks explored the deep-rooted socio-economic parallels between India and Russia, where women continue to serve as the silent backbone of domestic economies. She spoke powerfully on how household resilience, driven by women’s resourcefulness, has historically helped nations like India withstand global financial disruptions. Drawing from GTTCI’s initiatives in healthcare innovation, she described how Indian women are now leading AI-based diagnostics, digital maternal health platforms, and community health



entrepreneurship, particularly in underserved areas. She called for global cooperation to build a sisterhood of innovators across emerging economies and urged for greater investment in women—not only as contributors to societal wellness, but as architects of technology, policy, and enterprise. Her insights were received with admiration by co-panelists and delegates, and reaffirmed her position as a thought leader in inclusive development.

Ambassadorial Recognition under “Women for a Healthy Society” Initiative

On 20th June, Dr. Saluja was formally invited to serve as an Ambassador under the “Women for a Healthy Society” initiative, a distinguished honour conferred by the Roscongress Foundation and the Eurasian Women’s Forum. This special nomination recognized her sustained leadership in connecting health, technology, and gender equity through GTTCI’s ongoing programmes and international engagements. It marked yet another milestone in her journey as a thought leader and global representative of inclusive growth.



Participation in the Official Plenary Session

On 20th June 2025, the GTTCI delegation, led by Dr. Rashmi Saluja and accompanied by Dr. Gaurav Gupta, was invited as a Special Guest to attend the Official Plenary Session of the



St. Petersburg International Economic Forum (SPIEF) 2025. This high-profile session, regarded as the most significant moment of the forum, was addressed by global leaders and heads of state, reflecting the forum’s stature as a vital platform for international economic diplomacy. Among the keynote speakers were H.E. Vladimir Putin, President of the Russian Federation; H.E. Prabowo Subianto, President of Indonesia; H.H. Sheikh Nasser bin Hamad Al Khalifa of





Bahrain; H.E. Ding Xuexiang, Vice Premier of China; and H.E. Paul Mashatile, Deputy President of South Africa.

The presence of GTTCI leadership at this global gathering signified India's growing engagement with the Eurasian economic corridor and GTTCI's rising recognition as a credible institution driving international collaboration. The session emphasized themes such as global economic stability, regional integration, sustainable growth, and the

evolution of new trade mechanisms in a multipolar world. For GTTCI, this plenary session offered an unparalleled opportunity to engage with senior dignitaries, observe the emerging priorities of world leaders, and align its initiatives with the broader vision for global partnership.

During the proceedings, Dr. Saluja also held a cordial and constructive interaction with Mr. Alexander Shokhin, Chairman of the Russian Union of Industrialists



and Entrepreneurs (RSPP), reaffirming mutual interest in implementing the collaborative framework discussed earlier in Moscow. This dialogue, held in the backdrop of the Plenary Session, underscored GTTCI's focus on continuity and follow-through in building institutional bridges.

GTTCI's diplomatic mission to Moscow and St. Petersburg in June 2025 was not merely a sequence of engagements, but a strategically choreographed initiative to strengthen India–Russia economic relations and broaden India's presence in the Eurasian region. Through robust institutional partnerships, innovative financial proposals, and bold narratives on digital and gender inclusion, GTTCI brought to the fore India's capacity to lead from the front in shaping a more connected and equitable world. The visit exemplified GTTCI's mission to translate dialogue into development, policy into partnership, and vision into global impact.

Prime Minister Narendra Modi's ambitious five-nation diplomatic tour spanning Ghana, Trinidad and Tobago, Argentina, Brazil, and Namibia marks a significant chapter in India's global outreach. This extensive journey reflects India's strategic vision to deepen partnerships with emerging economies across Africa, Latin America, and the Caribbean, regions often overlooked yet rich with opportunities for sustainable growth, technological cooperation, and cultural exchange.

The tour underscores India's commitment to South-South cooperation, multilateralism, and inclusive development. Through these engagements, India aims to forge resilient economic ties, promote innovation, empower youth, and strengthen people-to-people relationships—all integral to India's evolving role as a global leader and a champion of equitable global governance.

India-Ghana: Revitalizing a Historic Partnership with Future-Focused Collaboration



India's relationship with Ghana is steeped in history, rooted in shared values from the Non-Aligned Movement era. PM Modi's visit renewed this partnership with a forward-looking agenda centered on digital transformation, youth empowerment, and sustainable development.

During bilateral talks with President Nana Akufo-Addo, the leaders emphasized cooperation in sectors like healthcare, education, agriculture, and infrastructure. India pledged to expand its support for Ghana's digital economy, promising to extend initiatives such as the Aadhaar-based digital identity platform and the UPI digital payment system, both proven tools for boosting financial inclusion and governance efficiency.

A highlight was the inauguration of a technology training center aimed at





equipping Ghanaian youth with 21st-century skills in AI, cybersecurity, and digital entrepreneurship. This initiative dovetails with India's larger vision of empowering youth as agents of economic transformation.

Trade and investment discussions also emphasized collaboration in renewable energy, pharmaceuticals, and agritech, with Indian companies exploring opportunities in Ghana's growing markets. Both nations reaffirmed commitment to combat climate change and promote clean energy, reflecting converging sustainable development goals.

Trinidad and Tobago: Honoring Diaspora Heritage While Building a Climate-Resilient Future



The stopover in Trinidad and Tobago was emotionally charged, given the island nation's substantial Indian-origin population. PM Modi's visit celebrated this rich cultural connection while laying the groundwork for deepened bilateral cooperation in critical sectors.

Engagements with Prime Minister Keith Rowley focused on renewable energy, fintech innovation, healthcare, and disaster risk reduction. New Memoranda of Understanding (MoUs) were signed covering Ayurveda research, digital payment integration, higher education exchanges, and renewable energy projects under the International Solar Alliance framework.

The inauguration of the Centre for Indian Studies at the University of the West Indies symbolized India's cultural diplomacy efforts, serving as a hub for academic research, language preservation, and cultural exchange. This initiative will enhance awareness and appreciation of Indo-Caribbean heritage among younger generations.

Additionally, joint projects in smart agriculture leveraging AI aim to bolster climate resilience among local farmers, addressing challenges posed by climate change. India's Skill India program was introduced to foster youth employment, entrepreneurship, and vocational training tailored to the Caribbean context.

Argentina: Building Strategic Bridges in Energy, Technology, and Innovation



In Argentina, PM Modi engaged with President Javier Milei to broaden bilateral cooperation across multiple strategic sectors. Argentina's vast lithium reserves are pivotal for India's ambitions in clean energy and electric mobility, making the lithium partnership a cornerstone of the visit.

The countries finalized a bilateral working group to streamline lithium mining, battery production, and green energy technologies. This collaboration supports India's broader vision of transitioning to sustainable, renewable energy sources while advancing industrial growth.





Beyond minerals, discussions encompassed biotechnology, pharmaceutical manufacturing, vaccine research, and agriculture technology. Both leaders expressed mutual commitment to food security and sustainable agricultural practices, highlighting the role of science and innovation in addressing global challenges.

An MoU on space cooperation was signed, facilitating joint satellite missions and STEM educational exchanges, underscoring the importance of scientific collaboration. Business delegations explored joint ventures in

IT, manufacturing, and agritech, aiming to diversify bilateral trade and stimulate innovation.

Cultural diplomacy events such as yoga workshops, Indian film festivals, and culinary exchanges were held to strengthen people-to-people ties and deepen mutual understanding.

Brazil: Strengthening the BRICS Alliance and Multilateral Cooperation



Brazil, a key BRICS partner, hosted PM Modi for high-profile discussions with President Luiz Inácio Lula da Silva centered on global governance reform, sustainable development, and inclusive economic recovery.

The two leaders launched the BRICS+ Development Innovation Forum, a platform designed to foster cooperation in fintech, green technology, digital health, and agriculture innovation among member and partner countries. This initiative reflects their shared commitment to democratizing access to technology and reshaping global economic governance.

Several bilateral agreements were inked in biotechnology, cybersecurity, defense collaboration, and biofuels development. India and Brazil also launched a joint innovation ecosystem to support startups focusing on AI, clean energy, and health technologies.

Scientific collaboration was highlighted by a memorandum between ISRO and Brazil's space agency for joint satellite projects, data sharing, and capacity building. India's digital governance platforms were also discussed for potential adoption in Brazil's smart cities initiative, strengthening ties in e-governance.

Namibia: A Historic Visit Heralding a New Era of Partnership



PM Modi's first-ever visit to Namibia was historic and deeply symbolic, building on decades of political solidarity rooted in the anti-colonial struggle.

Engagements with President Nangolo Mbumba covered a broad spectrum including green energy, vocational education, defense training, and environmental conservation. Key agreements focused on solar power projects to electrify rural areas, green hydrogen development, and joint wildlife conservation programs aimed at protecting endangered species such as the cheetah.

India's digital public infrastructure model, including the UPI payments system, was showcased and slated for pilot implementation, marking a milestone in digital cooperation in Southern Africa. The inauguration of the India-Namibia Friendship Park and cultural exchange programs reflected the deepening socio-cultural ties.

India also announced expanded scholarship programs under the "Study in India-Africa" initiative, targeting Namibian youth for studies in technology, medicine, and artificial intelligence, reinforcing India's role in building human capital across Africa.

- **Cultural Diplomacy and Diaspora Engagement:** The Indian diaspora played an essential role, serving as cultural ambassadors and economic bridges, with cultural centers, heritage corridors, and academic programs fostering enduring connections.

The tour unfolded against a backdrop of critical global challenges including climate change, vaccine equity, economic recovery, and multilateral institutional reform.

MEA Jaishankar in Beijing: Resetting the Compass of India–China Relations

Post-Galwan Reset: From Standoff to Strategy

In a major diplomatic move, External Affairs Minister S. Jaishankar visited China from July 14–15, 2025—his first since the 2020 Galwan Valley clash that brought India–China relations to a boiling point. The visit, centered around the Shanghai Cooperation Organisation (SCO) Foreign Ministers’ Meeting in Beijing and Tianjin, signaled a cautious but deliberate warming of ties between the Asian giants.

“Talk More, Clash Less”: Bridging the Trust Deficit

During his bilateral talks with Chinese Foreign Minister Wang Yi, EAM Jaishankar reinforced a central principle: “differences should not become disputes, nor competition become conflict.” The statement underscored India’s intention to stabilize ties through mutual respect and strategic dialogue.

Wang Yi reciprocated, emphasizing that China is “willing to work with India,” advocating for trust-based cooperation over suspicion and rivalry. He also called for both countries to jointly protect global supply chains and uphold multilateral trade systems—areas where both nations see overlapping interests.



LAC Tensions: Progress Made, But Road Ahead is Long

The fragile peace along the Line of Actual Control (LAC) remained a critical issue. EAM Jaishankar acknowledged positive steps since the disengagement at key flashpoints in October 2024 but insisted that more work remains. “De-escalation must go beyond disengagement,” he stated, reiterating that stability at the border is the foundation for overall bilateral progress.

Chinese leaders, including Vice President Han Zheng, affirmed their intent to deepen dialogue and avoid flare-ups—indicating that both sides understand the risks of renewed confrontation.

Economic Diplomacy: India Pushes Back on Trade Barriers

EAM Jaishankar also raised concerns over China’s trade practices, specifically pointing to restrictions on rare earth exports—vital for India’s growing electric vehicle, tech, and defence sectors. He urged China to roll back such “restrictive trade measures and roadblocks,” warning that economic imbalances could

undermine broader cooperation.

Interestingly, both sides echoed the need to maintain a stable, rules-based trade ecosystem, opening doors for recalibrating commerce amid shifting global supply chain dynamics.

Security & Spirituality: Expanding the Diplomatic Canvas

In his address at the SCO, EAM Jaishankar expanded India's position beyond bilateral issues, calling on member states to adopt a firm "zero tolerance" policy on terrorism. The comment, while broadly framed, resonated strongly within the context of India's regional security concerns.

On a softer note, he expressed gratitude to China for reviving the Kailash Manasarovar Yatra—suspended since 2019 due to pandemic and border tensions. The move, symbolic yet significant, illustrates an effort to strengthen people-to-people ties and cultural diplomacy.

Top-Level Engagement: Message Delivered to Xi Jinping

On the final day of his visit, EAM Jaishankar joined fellow SCO ministers in an audience with Chinese President Xi Jinping. He delivered greetings from President Droupadi Murmu and Prime Minister Narendra Modi, and reiterated India's desire for a balanced, forward-looking relationship anchored in trust and dialogue.

Earlier, his closed-door meetings with Wang Yi and Han Zheng were described by New Delhi as "constructive and forward-looking," with discussions touching upon practical outcomes like restoring direct air connectivity between India and China.

What This Visit Signifies

1. **Diplomatic Reboot** – The first high-level visit since Galwan, marking a political willingness to mend ties.
2. **Border Cooling** – Disengagement efforts signal easing tensions, but long-term peace still hinges on continued talks.
3. **Trade Course-Correction** – India is actively pushing back on trade asymmetries, especially in strategic sectors.
4. **Regional Voice** – India used the SCO platform to promote cooperation on counter-terrorism and regional connectivity.
5. **Symbolic Wins** – Restarting the Kailash pilgrimage and exploring aviation links reflect a renewed cultural and practical engagement.

Cautious Optimism: Can Diplomacy Outpace Distrust?

EAM Jaishankar's visit to China may not have delivered dramatic breakthroughs—but it achieved something equally valuable: reviving a working relationship. By balancing firm demands with openness to dialogue, India is signaling that cooperation is possible without compromising core interests.

The real test lies in implementation—will China follow through on de-escalation? Will trade barriers ease? Will dialogue replace deadlock? The coming months will reveal whether this diplomatic reset marks a turning point—or merely a pause in a cycle of tension.

As the world's two most populous nations reposition themselves amid global shifts, this visit may well serve as the opening chapter in a new, more stable India-China engagement.

PM Modi's Visit New Starting Point For Greater Cooperation: Argentine Envoy



Indian Prime Minister Narendra Modi's recent visit to Argentina has historic relevance that deserves to be highlighted. For the first time in 57 years, an Indian head of government made a bilateral visit to Argentina. Indian prime ministers—including PM Modi himself at the G20 in 2018—have visited our country in the past. But this is the first time an Indian prime minister has made a bilateral visit since Indira Gandhi travelled to Argentina in 1968, almost six decades ago.

PM Modi's visit to President Javier Milei takes place at a unique moment. Because India appears today on the international stage as a rising power called to play an increasingly prominent role in the world theatre.

Especially given that India, with 1.45 billion inhabitants, has become the world's most populous country surpassing the People's Republic of China.

At the same time, as is well known, India has achieved astonishing economic growth figures that have allowed it to achieve the status of the fourth largest global economy, with aspirations of becoming the third by the end of the decade.

The rise of hundreds of millions of people to the

middle class is the result of this economic expansion that has transformed the country in one of the world's major engines of global growth. Because, as someone once said, you can't be socially just if you're economically inefficient. And although, naturally, huge segments of the population still suffer from great material hardship, the improvement in the quality of life is an undeniable fact.

But none of this is coincidence. The economic rise of recent decades is the result of a process of deregulation and opening to the market economy since 1991. A path of modernising economic reforms launched more than three decades ago and deepened since 2014 under the leadership of PM Modi.

Reforms that effectively entailed the progressive abandonment of an economic system of heavy state regulation and control. This had led—in Indian terms—to the transition from "British Raj" to a "Licence Raj," which, through an endless web of regulations, slowed and complicated the private initiative of an enormously creative and vibrant population.

It is at this auspicious stage that the increasingly strategic bilateral relationship between our countries is unfolding.



With consolidated trade of around \$5 billion, India has become one of Argentina's top six trading partners. Currently, our country is the leading supplier of soybean oil to India and the third largest supplier of sunflower oil.

Recent years have marked a significant milestone for investment by Indian mining companies in our country. The province of Catamarca is home to Indian companies that are not only exploring for lithium but are also showing interest in copper and gold. It is worth noting the positive visit that Governor Raúl Jalil made a few months ago to strengthen and promote these ties.

These investments are particularly important as India advances its electric vehicle (EV) development, aiming to ensure a resilient and diversified supply chain for critical minerals essential to various industries in India.

In terms of energy, it is worth highlighting the two missions that YPF Chairman Horacio Marín made to New Delhi, where he signed a Memorandum of Understanding with companies in the sector, the first step toward making Argentina an energy supplier to meet India's unlimited demand.

In the strictly political sphere, we are particularly grateful to India for its historic support on the Malvinas Question before the United Nations, especially in the Decolonization Committee, where, for obvious historical reasons, India has an authoritative voice and a strong say on the matter.

In the field of defence cooperation, the armed forces of both countries have maintained a relationship based on shared experience, exchange opportunities and mutual support. This area is particularly notable for the university



courses on national defence and the exchange of mountain troops.

In nuclear matters, both countries are moving toward concluding a memorandum of understanding between our two nuclear regulatory authorities, and there is ample room to deepen existing cooperation in this area.

The firm condemnation of terrorism unites our countries. We have both been victims of the actions of transnational terrorism. Therefore, when an unacceptable terrorist attack occurred a few weeks ago in Pahalgam (Jammu & Kashmir), in which nearly 30 people were killed, our country was one of the first to express its condemnation, in line with the global anti-terrorism commitment that President Milei upholds as a guiding principle of his foreign policy.

Naturally, as readers will understand, the countless points of

cooperation between the two countries exceed the scope of a single column. But perhaps it is necessary to highlight the significance of PM Modi's visit to President Milei.

A trip that undoubtedly constitutes an auspicious new starting point for greater cooperation between two countries that maintain a high degree of objective complementarity and are destined to intensify the ties of friendship inaugurated almost eight decades ago.
