President Marcos Jr. in India

A Strategic Lift for India-Philippines Ties

A milestone state visit (August 4–8, 2025)

Philippine President Ferdinand R. Marcos Jr. paid a five-day State Visit to India from August 4 to 8, 2025, accompanied by First Lady Louise Araneta Marcos and a high-level ministerial and business delegation. The programme included a wreathlaying at Rajghat, bilateral talks with Prime Minister Narendra Modi at Hyderabad House, calls on President Droupadi Murmu and External Affairs Minister Dr. S. Jaishankar, and an outreach leg in Bengaluru—framing the visit as both ceremonial and purpose-driven. The trip coincided with the 75th anniversary of India-Philippines diplomatic relations, underlining the long arc of engagement between the two democracies.

From 'Act East' to Strategic Partners

The headline outcome was the formal elevation of the relationship to a **Strategic Partnership** on August 5, 2025. This step aligns closely with India's Act East Policy and Vision MAHASAGAR, and reflects the broadening convergence across political, security, economic, and people-topeople domains. The upgraded partnership is set to drive cooperation in defence and maritime security, trade and investment, healthcare and pharmaceuticals, science and technology, space, digital economy, fintech, connectivity, tourism, culture, and multilateral coordination.

What was signed: a practical roadmap

Alongside the declaration, the two sides released a Plan of Action (2025–29) to convert ambition into deliverables. A suite of instruments created new channels for steady cooperation:



- Terms of Reference for Air Staff Talks (Indian Air Force-Philippine Air Force) and Army-to-Army Staff Talks (institutionalising regular dialogue and training pathways).
- Implementation **Programme** in Tourism (2025-2028) to deepen visitor flows and destination collaboration.
- A Programme of Cooperation in Science & Technology (2025-2028) to seed joint R&D and innovation links.
- An MoU on Digital Technologies to expand collaboration across digital public infrastructure and emerging tech.
 - A Statement of Intent between ISRO and the Philippine Space Agency on peaceful uses of outer space.
 - Enhanced Maritime Cooperation Terms of Reference between the Indian Coast Guard and the Philippine Coast Guard, strengthening coordination on safety, surveillance, and capacity building.

Security at sea: signalling interoperability and trust

The regional security dimension was visible even beyond New Delhi. As the visit got underway, the **Indian and Philippine navies conducted their first-ever joint sail in the South China Sea**, underscoring growing maritime coordination and shared interest in a stable, rules-based Indo-Pacific. This operational signal complemented the new diplomatic architecture and showcased practical steps toward interoperability and maritime domain awareness.

Economic, technology and people links

While security cooperation drew the spotlight, the visit also widened economic and social bridges. Leaders highlighted the intent to boost **trade and investment**, tap complementarities in **healthcare and pharmaceuticals**, and scale collaboration in **digital economy and fintech**—areas where India's public digital platforms and innovation ecosystem can offer tangible partnership models. Tourism and science—technology programmes add near-term avenues for exchanges, joint projects, and knowledge transfer, while the space cooperation intent opens possibilities in remote sensing, disaster management, and satellite applications beneficial to an archipelagic country.

Why this matters now

The Strategic Partnership marks a qualitative reset in a relationship that has quietly gathered momentum. For India, the Philippines' geography and role in Southeast Asia make it a pivotal partner in **eastward engagement** and regional connectivity; for Manila, diversified security and economic ties with major Indo-Pacific players support resilience and opportunity. The timing—75 years after establishing ties in 1949—adds historical gravitas while setting a forward-looking agenda anchored in practical mechanisms and a multi-year plan.

The road ahead

With structures now in place—from staff talks and coast-guard coordination to technology MoUs and a 2025–29 action plan—the next phase is about **execution**: regular exercises and exchanges, faster project pipelines, deeper industry-to-industry links, and seamless people mobility. If sustained, these steps can translate the diplomatic upgrade into everyday cooperation across defence, digital, health, tourism and space—building a durable India–Philippines partnership that contributes to peace, stability, and shared prosperity across the Indo-Pacific.



South Korean Foreign Minister Cho Hyun's Visit to India: Strategic Depth at the 10-Year Mark

South Korean Foreign Minister Cho Hyun paid a bilateral visit to New Delhi from August 15-17, 2025, his first since taking office. The trip came immediately after India's Independence Day and Korea's National Liberation Day, underscoring the political salience both sides attach to ties as they mark 10 years of the India-Republic of Korea (RoK) Special Strategic Partnership.

A Broad, Forward-Leaning Agenda

External Affairs Minister S. Jaishankar and FM Cho held what both sides described as productive discussions aimed at expanding cooperation in trade, manufacturing, maritime links, and people-to-people exchanges, while opening new frontiers in semiconductors, artificial intelligence, clean energy, and defence. They also exchanged views on the Indo-Pacific and current global developments—areas where New Delhi and Seoul have steadily increased policy coordination. The talks explicitly framed the next phase of cooperation around resilient supply chains, high-technology collaboration and strategic stability in the region.



Security Convergence and Condemnation of Terror

The visit was also marked by a clear security alignment. Cho Hyun condemned the Pahalgam terror attack and expressed solidarity with the Indian government and people, reiterating Seoul's firm opposition to terrorism in all forms. New Delhi, in turn, welcomed this stance and noted Korea's supportive engagement with Indian parliamentary outreach in the recent past. The mutual messaging signals continuity in counter-terrorism cooperation and a widening comfort level on hard-security conversations alongside economic and technological ties.

Technology, Energy and Defence: The Next Big Push

Among the most significant deliverables of the engagement was the focus on next-generation industries. By prioritising Al and semiconductor ecosystems, both sides set the tone for deeper industry-to-industry partnerships, potential co-development opportunities, and greater integration



of Korean manufacturing strengths with India's market scale and digital capacity. Clean energy featured prominently as well, with an emphasis on accelerating collaborations that can reduce carbon intensity and expand green technologies. On defence, the ministers discussed ways to enhance ties—complementing existing industrial linkages and ongoing conversations around maritime security in the wider Indo-Pacific.



Culture and People-to-People Ties: A Growing Soft-Power Bridge

Beyond strategy and commerce, Cho Hyun spotlighted the cultural tailwinds propelling the relationship. He noted the surging interest among Korean youth in Indian culture and a parallel uptick in Indian enthusiasm for Korean culture—from cinema and music to cuisine. The minister floated joint film production as a tangible avenue to harness this momentum, reflecting a broader belief that cultural industries can underpin long-term trust and understanding between the two societies. The remarks also echoed longstanding civilisational links, often cited as an enduring bedrock for modern engagement.

A Personal Continuity Note

Cho Hyun drew on his prior tenure as Korea's Ambassador to India (2015–2017), observing that India has undergone significant changes over the past decade, and praising the pace and direction of reform and growth. His familiarity with India's policy landscape—and his early return to New Delhi scarcely weeks into his new roleadded a note of continuity and momentum to the diplomatic choreography.

Why This Visit Matters

Three elements make this visit consequential. First, it bookends a decade of the Special Strategic Partnership with a **forward-looking**

agenda that shifts the centre of gravity to technology, **clean energy, and defence**, while sustaining the traditional engines of **trade and manufacturing**. Second, it strengthens strategic alignment on the Indo-Pacific and counter**terrorism**, areas where policy convergences are increasingly vital. Third, it recognises that soft power—from cultural exchange to creative industries—will be a force multiplier, deepening public support and commercial possibilities alike.

The Road Ahead

With the milestone 10-year anniversary as both context and catalyst, New Delhi and Seoul have signalled intent to institutionalise high-tech collaboration, expand maritime and defence coordination, and scale peoplecentric exchanges. If translated into concrete projects especially in chips, AI, green technologies, and cultural co-production—the visit could mark the start of a more comprehensive, innovation-driven phase in India-Korea relations.



Kartavya Bhavan Inaugurated:

A Green, Integrated Nerve Centre for Governance

A milestone at Kartavya Path

On 6 August 2025, Prime Minister Narendra Modi inaugurated Kartavya Bhavan at Kartavya Path in New Delhi, marking the rollout of India's Common Central Secretariat (CCS). He inspected the new complex with Housing & Urban Affairs Minister Manohar Lal Khattar and later addressed a public programme at the venue. The event signalled a decisive shift from a scattered ministerial estate to an integrated, technology-forward centre for governance.

What is Kartavya Bhavan?

Also known as Central Secretariat Building–3, Kartavya Bhavan is the first of a planned set of CCS buildings under the Central Vista redevelopment. It consolidates key ministries that have long operated from ageing structures such as Shastri, Krishi, Udyog and Nirman Bhawans. The complex spans about 1.5 lakh sq m across two basements and seven floors, and is designed to streamline inter-ministerial coordination, speed up decision-making and reduce the government's logistical footprint.

Who will sit here?

The building will host the Ministries/Departments of Home Affairs, External Affairs, Rural Development, Micro, Small & Medium Enterprises (MSME), Personnel & Training (DoPT), Petroleum & Natural Gas, and the Office of the Principal Scientific Adviser. Co-locating these portfolios—spanning internal security, foreign policy, rural development, enterprise, human resources for governance, energy and science—creates a cluster with wide policy synergy and daily operational interdependence.

Built for the 21st century

Kartavya Bhavan has been conceived as a secure, IT-enabled workplace. Features include ID-card based access, integrated electronic surveillance, a central command system, and digital-ready work halls and meeting suites. The administrative core is complemented by modern conference facilities and flexible workspaces intended to support multiagency teams and rapid policy cycles.



Sustainability by design

The project targets a GRIHA-4 green rating and embeds a suite of sustainability measures: double-glazed façades, advanced HVAC, motion-sensor LED lighting, smart lifts, and an energy management system that together aim to cut energy use by around 30%. Rooftop solar is expected to generate more than 5.34 lakh units of electricity annually, while solar water heaters will meet over a quarter of daily hot water needs. A zero-discharge approach integrates wastewater treatment and solid-waste processing, with EV charging and recycled construction materials further reducing the environmental footprint.

Why this matters

For decades, ministries operated from buildings erected in the 1950s–70s—costly to maintain and sub-optimal for modern workflows. By bringing major portfolios under one roof, the CCS model promises faster file movement, shorter decision chains and shared digital infrastructure. It also addresses fiscal prudence: the government has flagged significant recurring outlays on hired space for dispersed offices; consolidating functions within the CCS is expected to curb those costs and improve asset utilisation.

Part of the Central Vista blueprint

Kartavya Bhavan sits within a broader plan to co-locate and modernise central government offices. The CCS is envisaged as a campus of around ten buildings by the latter 2020s, with subsequent phases intended to bring virtually all ministries within a unified precinct; an Executive Enclave is planned to follow. At present, many ministries are spread across and beyond the Vista—consolidation aims to anchor them in an integrated complex aligned to contemporary standards of security, sustainability and efficiency.

The Prime Minister's message

In his address, the Prime Minister framed Kartavya Bhavan as an institution that will help set the direction of a developed India—an emblem of duty-driven governance and efficient service delivery during the "Amrit Kaal." He linked the building's capabilities to national goals, stressing that modern, citizen-centric administration rests on robust infrastructure, seamless coordination and smart, sustainable systems.







The road ahead

With the first CCS building operational, the next task is execution: phased movement of ministries, onboarding of common digital platforms, and rigorous commissioning of the building's green and security systems. If implemented with discipline, Kartavya Bhavan can translate architectural ambition into everyday administrative gains—faster policy formulation, tighter programme monitoring and a better citizen experience—while setting benchmarks for future government infrastructure.



India-China Relations **Enter a New Phase with** Wang Yi's Delhi Visit




Chinese Foreign Minister Wang Yi's two-day visit to New Delhi on August 18-19, 2025, marked the most substantive engagement between India and China since their border crisis erupted in 2020. The trip combined high-level political meetings with a structured round of boundary talks, producing a rare set of concrete outcomes and a noticeably warmer tone from both sides.

High-Level Meetings: PM, NSA and EAM

Wang met Prime Minister Narendra Modi, External Affairs Minister S. Jaishankar and National Security Adviser Ajit Doval. Modi underlined that "stable, predictable, constructive" ties would benefit regional and global peace, and he conveyed his acceptance of President Xi Jinping's invitation to attend the Shanghai Cooperation Organisation (SCO) summit in Tianjin later this month. Jaishankar's talks focused on preventing differences from becoming disputes, while Doval co-chaired boundary discussions under the Special Representatives (SR) mechanism.

Boundary Talks: A Ten-Point Consensus

The centrepiece of the visit was the 24th round of SR-level talks on the boundary question, where both sides endorsed a ten-point consensus. Key elements included: acknowledging border calm since the previous round; reaffirming the 2005 Political Parameters and Guiding Principles as the framework for a "fair, reasonable and mutually acceptable" settlement; creating an expert group to explore "early harvest" delimitation in appropriate sectors; setting up a new working group on effective border management; expanding General-Level Mechanisms to the eastern and middle sectors; discussing de-escalation principles and modalities; enhancing cooperation on trans-border rivers with emergency hydrological data-sharing; reopening three traditional border trading markets



(Renqinggang-Changgu, Pulan-Gunji and Jiuba-Namgya); and holding the 25th round in China in 2026.

Tone and Optics: "Borders Have Been Quiet"

Public messaging reflected a tentative thaw. Doval said engagements have shown an "upward trend," noting that "borders have been quiet" in recent months—language that India has used sparingly since 2020. Wang Yi, for his part, called the moment an "important opportunity" to improve relations and pledged to work towards specific boundary goals while creating conditions for broader normalization.

Economic and Practical Steps

Beyond the boundary file, discussions covered trade, connectivity and people-to-people exchanges. Indian readouts highlighted conversations

on economic and trade issues, pilgrimages, river datasharing, border trade and connectivity. Reporting in India also indicated Chinese assurances to address three Indian concerns—access to rare earths, fertilisers and tunnel-boring machines—areas where supply constraints have hampered infrastructure and industry. Separately, international coverage noted progress on resuming direct flights and processing journalist visas, practical steps that would re-knit disrupted ties.

Multilateral Context: SCO as the Next Test

The timing of the visit was calibrated to upcoming multilateral engagements. Wang conveyed Xi's invitation for Modi to attend the SCO summit in Tianjin, and Modi's acceptance signals political will to keep the channel open. Beijing-based commentary framed the visit as part of a broader stabilization effort, with both sides expected to coordinate positions in the SCO and other forums, even as





differences persist. The summit will offer a visible next milestone to test whether the New Delhi consensus can translate into sustained de-escalation and incremental economic reopening.

What Changed—and What Hasn't

Three shifts stand out. First, the boundary dialogue moved from crisis management to a structured agenda with new mechanisms (expert and working groups) and sector-specific confidence-building steps, including reopening border markets. Second, political top-cover returned: the prime ministerial engagement and SCO optics restore leader-level signaling absent in earlier years. Third, both sides are again discussing trade facilitation and mobility, a prerequisite for any durable normalization. Yet, fundamentals remain delicate: neither

side announced verified troop reductions or a sectoral settlement; de-escalation is still at the level of "principles and modalities," and mutual mistrust around patrol rights and infrastructure near the Line of Actual Control persists.

Outlook: Managed Competition with Guardrails

If implemented, the ten-point agenda could reduce friction by clarifying protocols, reviving local commerce, and insulating civilian ties from periodic flare-ups. Success will hinge on steady military-to-military engagement, transparent river data-sharing during emergencies, and the credibility of any "early harvest" delimitation effort. With both governments publicly framing ties as stabilizing—and markets and ministries signaling targeted cooperation—India and China appear to be edging toward managed competition with thicker guardrails. The weeks around the SCO summit will reveal whether that trajectory holds.

On the 79th Independence Day, Prime Minister Narendra Modi delivered a wide-ranging address from the Red Fort, combining administrative ambition with cultural symbolism. While much of the speech focused on reforms, self-reliance, and economic transformation, it also carried a historic acknowledgment: a salute to the Rashtriya Swayamsevak Sangh (RSS) on its centenary. By balancing policy commitments with a tribute to one of India's most influential civic organisations, Modi presented a vision of a Viksit Bharat rooted both in modern governance and cultural continuity.

Salute to the RSS at 100 Years

In one of the most significant moments of his speech, PM Modi praised the RSS, calling it the "world's biggest NGO" and honouring its 100-year journey of service to the nation. He lauded the organisation's contributions in fields such as rural development, social cohesion, cultural preservation, and humanitarian relief, emphasising that the RSS has inspired generations of Indians to dedicate themselves to voluntary service.

By placing this recognition at the heart of his address, Modi elevated the RSS centenary into a national milestone. It marked one of the strongest acknowledgments of the Sangh from the Red Fort, underscoring its role in shaping India's civic and social identity.

Analysts viewed this gesture as both symbolic and

strategic. For supporters, it was a proud moment of recognition for a century of grassroots mobilisation. For political observers, it reflected Modi's intent to integrate cultural and ideological affirmation with his governance narrative. The salute to the RSS stood as a reminder that India's progress is not only measured by economic reform but also by institutions that strengthen its social fabric.

Simplifying Laws and Governance

Beyond symbolism, the Prime Minister set out a strong reform agenda. He noted that in recent years:

- Over 40,000 unnecessary compliances have been abolished.
- More than 1,500 outdated laws have been repealed.
- Around 280 provisions were removed in the latest parliamentary session.

These steps, Modi explained, were not just bureaucratic exercises but part of a larger mission to make governance simpler, faster, and more accessible. Reform, he said, is about changing how citizens experience the state in their daily lives.

Fiscal and Judicial Reforms

The speech highlighted reforms that directly touch citizens:

- Income Tax Reform and Faceless Assessment to improve transparency.
- Zero tax for annual income up to ₹12 lakh, offering

- relief to the middle class.
- Replacement of outdated criminal laws with the Bhartiya Nyay Sanhita, simplifying justice and legal processes.

Together, these reforms project a government that is shifting from control to facilitation, ensuring governance works for the people.

Empowering Entrepreneurs and MSMEs

The Prime Minister stressed that reducing compliance burdens is critical for **startups**, **small businesses**, **and MSMEs**. Simplification of rules, protection from arbitrary legal actions, and reduced compliance costs are meant to encourage innovation, economic self-reliance, and competitiveness.

Task Force for Next-Generation Reforms

Modi announced the creation of a **Task Force for Next-Generation Reforms** with a clear mandate to:

- Review laws governing economic activities.
- Reduce compliance costs across industries.
- Safeguard entrepreneurs from outdated legal provisions.
- Streamline regulations for ease of doing business.

This body will work within strict timelines, reflecting the

government's urgency to institutionalise reforms and sustain momentum.

Next-Generation GST Reforms

Among the most awaited announcements was Modi's pledge to introduce **Next-Generation GST reforms by Diwali.** These reforms will reduce taxes on daily-use items, described by the Prime Minister as a "**Diwali gift**" to citizens. The move is aimed at easing the burden on households while







stimulating broader economic activity.

Vision for the Future

In his concluding remarks, Modi urged India to focus not on the limitations of others but on **expanding its own line of progress**. In an era of rising economic self-interest globally, he stressed that India must build resilience, create opportunities, and empower its citizens to lead the way towards a **Viksit Bharat**.

Outlook: Reform with Cultural Roots

This year's Independence Day address was distinctive for blending hard policy measures with cultural recognition. The reform announcements—including GST changes, legal simplifications, and institutional mechanisms like the Task Force—demonstrated administrative ambition. At the same time, the salute to the RSS on its 100th year placed cultural institutions at the centre of the national narrative.

If implemented effectively, the reforms can deliver tangible ease for citizens and businesses alike. And by acknowledging the RSS, Modi signaled that India's journey of transformation draws not only from governance innovations but also from the strength of long-standing social movements

PM Modi's address projected a dual vision: a modern, reform-driven India and a

nation anchored in civic traditions. By honouring the RSS alongside announcing sweeping economic and governance changes, the Prime Minister underscored that building a Viksit Bharat requires both structural reform and cultural recognition. The success of this vision will depend on turning promises into action while ensuring inclusivity in India's march forward.

Fiji's Prime Minister Sitiveni Rabuka paid his first official visit to India from August 24–26, 2025, culminating in a joint statement themed "Partnership in the spirit of Veilomani Dosti." The three-day agenda blended symbolism with substance: commemorating deep historical ties while unveiling a modern cooperation slate across defense, health, climate, trade, and people-to-people links.

Defence and maritime security: from intent to action

Security cooperation took center stage. The leaders welcomed outcomes from the inaugural Joint Working Group on Defence, covering UN peacekeeping, military medicine, white-shipping information exchange, and capacity-building for Fiji's forces. India will establish a defence wing at its High Commission in Suva, gift two ambulances to Fiji's military, stand up a Cyber Security Training Cell, and schedule an Indian Naval Ship port call—steps that anchor day-to-day interoperability and maritime

domain awareness in Fiji's EEZ.

Business-facing coverage underscored the same theme: both sides are strengthening defence ties and maritime security cooperation, aligning practical training and equipment support with Fiji's island security priorities.

Health and human development: a flagship hospital for Suva

The visit delivered a marquee project: an MoU to design, construct, commission, operate, and maintain a 100-bed Super Specialty Hospital in Suva—India's largest grant-in-aid health project in the Pacific. Complementing brick-and-mortar care, the package includes integration with e-Sanjeevani telemedicine, support for Jan Aushadhi (People's Pharmacies) to widen access to affordable generics, a second Jaipur Foot camp, and specialized care in India for up to 10 Fijians



under the "Heal in India" program. Together, these measures address both acute capacity gaps and long-run system resilience.

Economy, agriculture, and trade: seeding resilience

Both governments noted untapped potential in bilateral trade, which has hovered around US\$80 million in recent years, and moved to diversify the portfolio. Fiji granted market access to Indian ghee, while New Delhi announced 12 agricultural drones and two mobile soil-testing laboratories to boost productivity—especially in the sugar



sector—alongside an ITEC expert for the Fiji Sugar Corporation and targeted training. The development partnership track advanced with a Quick Impact Project for clean drinking water in Tubalevu. Business linkages widened via MoUs among FDB-NABARD (rural finance), **BIS-DNTMS** (standards). NIELIT-Pacific Polytechnic (digital skills), CII-FCEF (business chambers), and HLL Lifecare (Jan Aushadhi supply).

People-to-people and culture: mobility, language, heritage

A new Declaration of Intent on Migration and Mobility will streamline movement for professionals students. India will depute Hindi-cum-Sanskrit teacher to the University of Fiji and support training for Fijian pundits, with International Geeta an Mahotsav also slated Fiii—measures that reinforce living cultural links. These initiatives sit atop a unique social foundation: Indo-Fijians—descendants of the Girmitiyas who arrived between 1879 and 1916—constitute roughly 38% of Fiji's population,

sustaining enduring educational, cultural, and commercial connections with India.

Climate and the Indo-Pacific: aligning blueeconomy priorities

On climate and resilience, both sides reaffirmed cooperation through India's Mission Life, the International Solar Alliance (including an upcoming STAR Centre at Fiji National University), the Coalition for Disaster Resilient Infrastructure, and the Global Biofuels Alliance. Strategically, Fiji signaled







interest in joining the Indo-Pacific Oceans Initiative, and the leaders stressed a free, open, secure, and inclusive Indo-Pacific. Multilaterally, Fiji reaffirmed support for India's permanent seat in a reformed UN Security Council and for India's 2028–29 UNSC nonpermanent bid.

Counter-terrorism and regional stability

joint statement condemned terrorism unequivocally, including this year's **Pahalgam** attack, and committed to cooperation against radicalization, terror finance, and misuse of emerging technologies. The security plank complements maritime and cyber initiatives. creating whole-ofgovernment framework for stability.

Why this visit matters

Rabuka's Delhi trip moves India-Fiji ties from warm sentiment to operational partnerships. Health infrastructure and telemedicine target everyday welfare; drones, soil labs, and rural finance agreements speak food security and climate


resilience; defense and cyber measures sharpen maritime and homeland security; and the mobility, language, and heritage tracks deepen people-to-people trust. With deliverables now mapped and timelines implied by MoUs and planned deployments, the relationship gains a repeatable mechanism—working groups, training pipelines, and port calls—that can be scaled or adapted as needs evolve across the Blue Pacific. If both sides sustain this cadence, Veilomani Dosti will read less like a motto and more like a measurable, annual program of action.



















Ethiopia to Host Climate **Summit:** \overline{ACall} for Global Action

Ethiopia, a nation with over 3,000 years of civilisation and home to more than 80 ethnic groups, is often referred to as the "Land of Origins" owing to its status as the cradle of human ancestry. The country is set to host the second Africa Climate Summit (ACS2) from September 8 to 10, 2025, in its capital, Addis Ababa. As the second most populous and geostrategic Country in Africa, Ethiopia plays a significant role on the continent.

Addis Ababa is emerging as an important diplomatic hub, frequently hosting various international conferences and summits. This trend is enhancing the city's reputation as a centre for global dialogue and collaboration.

In recent years, the growing concern over climate trends and their potential impacts on both the environment and the socio-economic fabric of societies has positioned climate change as a critical topic of global discourse. Before delving into the causes, evidence, potential impacts, and adaptations related to climate change, it is essential to first understand what climate change entails.

Climate change is a pervasive global threat that has been unfolding over an extended period, with its manifestations posing significant risks to the stability of societies, as well as to natural and managed ecosystems. The rise in ambient temperatures and the alteration of related environmental processes are directly linked to increasing concentrations of anthropogenic greenhouse gases (GHGs) in the atmosphere.

While climate change can result from natural internal processes or external forces, its persistent anthropogenic influences have become increasingly evident. In the 21st century, issues such as migration, terrorism, and the proliferation of weapons of mass destruction have emerged as critical challenges that transcend national borders. Among these, climate change stands out as one of the most formidable challenges humanity faces in its relationship with nature. The complexity of climate issues necessitates a collective global response, emphasizing the urgent need for international collaboration and action to address this pressing crisis.

As a nation committed to addressing the pressing of climate change, Ethiopia has aligned its efforts with the Paris Agreement's goals of limiting the global average temperature increase to well below 2 °C above preindustrial levels, and striving to limit the increase to 1.5 °C. The Ethiopian government recognizes the devastating impacts of climate change on its people, environment, and economy, and is committed to taking immediate global action to enhance climate resilience and reduce greenhouse gas (GHG) emissions.





AFRICA CLIMATE SUMMIT 2

8–10 September, 2025 Addis Ababa, Ethiopia

Ethiopia's long-term low emissions development strategy (LT-LEDS) aims for net-zero emissions by 2050, setting an ambitious example for others to follow. This strategy complements Ethiopia's Climate Resilience and Green Economy strategy, which was outlined in the Ten-Year Development Plan: A Pathway to Prosperity (2021-2030). This plan aims for an annual economic growth rate of 10.2% while prioritizing the establishment of a climate-resilient green economy. It includes specific targets to enhance Ethiopia's capacity for reducing greenhouse gas emissions from 92.7 MtCO2e to 162.3 MtCO2e by 2030.

Despite these ambitious goals, current projections indicate that emissions may rise to between 197-220 MtCO2e by 2030, representing a 62-81% increase compared to 2010 levels. In response to this challenge, Ethiopia has taken significant steps under leadership of PM Abiy Ahimed (PhD) such as green legacy initiatives planting billion of trees every year, a large-scale reforestation program targeting 700 million trees in 2025. banning the import of all internal combustion engine vehicles in 2024, becoming the first country to do so. Additionally, policies have been introduced to incentivize electric vehicle (EV) adoption, including tax exemptions and reduced import tariffs for locally assembled EVs.

The forthcoming ACS2 will be co-convened by the Ethiopian government and the African Union Commission under the theme "Accelerating Global Climate Solutions: Financing for Africa's Resilient and Green Development." The summit will showcase Africa-led climate solutions and focus

on unlocking climate finance, positioning the continent as a key player in the global climate response.

The urgency of the climate crisis cannot be overstated; 2024 is projected to be the hottest year on record, with 2025 likely to surpass it. African nations, despite contributing less than 4% of global greenhouse gas emissions, are disproportionately affected by climate change, often spending over 5% of their

GDP on climate-related responses. This diverts critical resources from essential development sectors such as health and education.

The ACS2 aims to bring together 45+ African heads of state, policy makers, scholars and different stake holders, to spotlight Africa's leadership and innovation in combating the climate crisis. It seeks to establish a united African voice ahead of COP30, emphasizing principles of multilateralism, equity, and respect for international rights frameworks. The summit will champion partnerships that promote nature-centred investments, innovative solutions, and sustainable practices.

Ethiopia calls upon the international community to support Africa in creating green energy solutions and building climate-resilient economies. The ACS2 will serve as a platform for mobilizing political and financial action to address the climate crisis, advocating for reforms in the global financial system that reflect Africa's realities and priorities, particularly in renewable energy access and climate adaptation.

In conclusion, the ACS2 represents a pivotal opportunity for African nations to assert their leadership in global climate governance, fostering a future that prioritizes sustainability, resilience, and equitable development.

ACS2 will also deepen South–South cooperation and foster a new era of global partnerships rooted in equity, innovation, and African-led solutions. The long-term impact will be a strengthened continental position that not only influences COP30 but also institutionalizes Africa's leadership

in global climate governance, through collective efforts and international support, Africa can catalyse transformative change in the global response to climate change.

Climate change has no borders our solution should not either.

- 2. Global headline inflation projected to slow to 4.2 % in 2025 and 3.6 % in 2026 - Inflation outlook softens though regional disparities remain pronounced.
- 3. IMF warns of major downside risks from tariff escalation and geopolitical tensions – Rising uncertainty could undermine confidence and stability.
- Emerging and developing economies set to grow **4.1 % in 2025, easing to 4.0 % in 2026** – Driven by resilience in Asia but vulnerable to fading front-loading effects.
- 5. IMF raises U.S. 2025 growth projection to 1.9 % -Boosted by recent fiscal stimulus measures.
- 6. Euro-area forecast nudged to 1.0 % in 2025 and 1.2 % in 2026 – Supported by exceptional export performance in Ireland.


